#### THE SOLUTION / WORK FLOW

Indo-Japan was importing raw materials, as well as sourcing them locally for usage by specific Japanese customers.

These Japanese customers had set up plants in India to supply finished rubber & plastic material, for sale of finished automotive & engineering goods to customers such as Suzuki, Toyota, Honda, Nissan, Mitsubishi, Hitachi & Sony.

The final products are used for auto, infrastructure, telecom & other engineering applications.

Now we have forward integrated to sell pre-mixed rubber compounds & dispersions to such customers, who find it easier to use the products given constraints of power, technology & training within their organisations. We commit to Japanese quality & standards for the products sold, using technology & trained consultants from Japan who help us arrive at the right product for sale.

## **HOW WE OPERATE**

We are currently working from one central office at Chennai.

Products are imported into Chennai and sold to customers, or sourced locally & sold to customers, depending on the suppliers. We have a tie up in outsourced manufacturing with two plants — one in South & one in West India for Compounds & Dispersions.

We have a control lab installed at the central office in Chennai, which helps us manage the out sourced production.

We have mapped compounding requirements & growth of current compounders in India since 2007. The study has helped us position our product appropriately. It gives a polymerwise break up of users & applications. A similar study is on going for the dispersion business.
